Employer Billing Statements for unemployment insurance contributions are available through the online Employer Self Service (ESS) portal as of March 2020. Paper statements will only be mailed for the months of March, June, September, and December.

Even after you qualify for unemployment insurance benefits by meeting the threshold eligibility requirements, in some limited instances you may be overpaid benefits. If you received a notice of overpayment, then know that you can fight the claim.

UI provides temporary income support to workers who have lost their jobs through no fault of their own and have earned enough wages within a specific base period to qualify.

Filing a weekly claim online is a requirement of continued eligibility for unemployment insurance. If you do not file your weekly claim, you will not receive payment for that week. No exceptions. You may file your weekly claim on Sunday from 8:00 AM to 7:30 PM or Monday to Friday from 8:00 AM to 5:30 PM.

### Unemployment Insurance Assistance | Department of Labor

If your claim status is "Filed," with a zero (\$0) amount in the Weekly Benefit Rate (WBR), we are still reviewing your claim. Some people with a \$0 balance, such as those who are self-employed, per federal law, will receive benefits under the Pandemic Unemployment Assistance (PUA) program.

You should receive an Unemployment Insurance Benefit Determination in the mail. This will detail whether you have enough insured wages to establish a claim. It does not mean you are approved to receive benefits. A notice of claim filing and request for separation information will be sent to your most recent employer.
