Ratifying the Constitution. Once the Constitution of the United States was written in 1787 at the Philadelphia convention, the next step was ratification. This is the formal process, outlined in Article VII, which required that nine of the thirteen states had to agree to adopt the Constitution before it could go into effect.

The Constitution was written and signed, but its ratification by the people was far from certain. As specified in Article VII of the Constitution, two-thirds, (or nine of the then-thirteen states) would have to ratify the Constitution before it could go into effect in those states.

Most of us are familiar with at least the outline of this story, perhaps from an American History or Civics class: the Constitution had to be ratified by at least 9 states in order to replace the Articles of Confederation (in those states) and a debate went on between the "Federalists" who supported the Constitution and the "Anti-Federalists" who felt that it curtailed states' rights too much and would lead to tyranny.
